Statement of intent

At Broadway Infant School, we see the value in collective worship and adhere to our statutory duty by providing an opportunity to take part in an act of collective worship a day. This time will enable pupils to explore their own beliefs and consider spiritual and moral issues.

The act of daily collective worship will be wholly or mainly of a broadly Christian character; however, other faiths and cultures will be represented.

Collective worship provides the opportunity for the school to meet together in a variety of contexts and enables participating pupils and staff to consider events of the world and appreciate the rich tapestry of human experience and existence.

This policy outlines how our school implements collective worship within our daily routines, including the aims of collective worship and how pupils can be withdrawn.

1. Legal framework

- 1.1. This policy has due regard to legislation including, but not limited to, the following:
 - The School Standards and Framework Act 1998
- 1.2. This policy also has due regard to guidance, including, but not limited to, the following:
 - DfE (1994) 'Religious Education and Collective Worship'
- 1.3. This policy will be implemented alongside the following school policies:
 - RE Policy

2. Definition of collective worship

- 2.1. For the purpose of this policy, "**collective worship**" is an act which is additional to, and separate from, ordinary school activities.
- 2.2. To "**take part**" in collective worship implies more than a passive attendance, such that it should have the ability to elicit responses from pupils even though they may not feel able to actively identify in the act of worship on a particular occasion.

3. Aims of collective worship

- 3.1. Collective worship aims to:
 - Enable pupils to consider spiritual and moral issues, as well as explore their own beliefs.
 - Encourage participation and response via active involvement or through listening and participating in the worship offered.
 - Provide pupils with the opportunity to plan, lead or contribute to discussions on key themes and topics, e.g. morality.
 - Provide a peaceful environment to enable stillness, prayer and reflection.
 - Help pupils to develop an awareness of their community and the spirit of helping others.
 - Develop a spirit of community and an understanding of individuals with other beliefs.
 - Acknowledge diversity and affirm each individual's life stance, whether religious or not.
 - Promote a common ethos and shared values.
 - Reinforce positive attitudes.

4. Organisation and planning

- 4.1. The school will implement collective worship in line with advice given by the Standing Advisory Council on Religious Education (SACRE).
- 4.2. Every pupil will participate in the act of collective worship unless they have been withdrawn in line with [section 7](#) of this policy.
- 4.3. Worship will be of a broadly Christian character; however, there will be influences from other religions found in the local community. The content of all acts of collective worship will be considered to ensure suitability and relevance to pupils of all ages and backgrounds.
- 4.4. The Deputy Head Teacher is responsible for creating the agenda for collective worship. Each assembly held will have a theme relevant to current affairs and other festivals and/or celebrations.
- 4.5. The act of worship forms part of each assembly, which can be either a whole-school assembly, a year group or class assembly.
- 4.6. The school may invite visitors or guest speakers to speak during collective worship, in accordance with the timetabled theme.

5. Weekly collective worship programme

- 5.1. The school aims to deliver a varied collective worship programme to pupils. The current schedule is outlined in the table below:

Day of the week	Delivery of programme
Monday	A whole-school worship assembly is delivered by the headteacher.
Tuesday	A whole-school worship assembly is delivered by one of the teaching staff.
Wednesday	Whole-school singing assembly is held and conducted by our music subject leader. Time for reflection is included during the assembly.
Thursday	A class assembly takes place in the classroom.
Friday	A whole-school celebration assembly is delivered by the headteacher.

- 5.2. Time for reflection, prayer and hymns will form a part of collective worship.
- 5.3. All topics covered will be suitable to the age of pupils participating in collective worship and will be inclusive for all needs.

6. Implementation

- 6.1. The school aims to promote rich and meaningful experiences of collective worship that are appropriate to pupils' needs, ages and interests by:
 - Enabling children to consider spiritual and moral issues
 - Giving children the opportunity to reflect on the values that are of a broadly Christian nature and on their own beliefs.
 - Encourage participation and response.
 - Develop in children a sense of community spirit.
 - Promotion of a common ethos, shared values and positive attitudes.
 - Teaching children to be considerate and respectful when they or others choose to worship.
- 6.2. The school will take into account pupils of different ages and abilities when delivering the collective worship programme.
- 6.3. The school will arrange for learning mentors to assist pupils with SEND if the need arises.

7. Right to withdraw

- 7.1. Parents have the right to withdraw their child from collective worship and are not required to provide a reason for doing so.
- 7.2. Parents will be encouraged to discuss their decision with the headteacher following a request of withdrawal in terms of:
 - The elements of worship in which the parent would object to the pupil taking part in.
 - The practical implications of their withdrawal.
 - Whether the parent will require notice in advance of such worship, and if so, what period of notice is preferred.

Alternative provision, which will be consistent with the overall purposes of the school curriculum, will be arranged for pupils who are withdrawn from collective worship.

8. Monitoring and review

- 8.1. This policy will be reviewed every three years.
- 8.2. Any changes made to this policy and the collective worship programme will be communicated to all members of staff.
- 8.3. The scheduled review date for this policy is March 2024.
